

## 1. General Training Program (2023) for Additional District & Sessions Judges and Civil Judges.

The Punjab Judicial Academy (PJA) is dedicated to enhancing the capacity and professional competency of judicial officers and court personnel through both pre-service and in-service training programs. General Training Program (GTP) is one of these initiatives for Judicial Officers, was launched to refresh their legal knowledge, equip them with the latest case law, and enhance their competency, judicial ethics, and fair administration of Justice.

In 2023, the PJA introduced a new six-day GTP, designed to meet the in-service training requirements of judicial officers in Punjab. The main objective of this program was to address deficiencies in decision-making during judicial proceedings, with a particular emphasis on improving **judges' judgment writing skills**. This initiative will help to ensure a fair administration of the Judicial System.

Additionally, the GTP also emphasizes the development of research skills and improvement of decision making abilities among judicial officers. Overall, the GTP is a comprehensive training program designed to equip judicial officers with the skills and knowledge necessary to deliver justice fairly and efficiently.

#### a) GTP for Additional District & Sessions Judges:

The Punjab Judicial Academy organized a new six day GTP (2023) for 502 Additional District & Sessions Judges (AD&SJs) in 21 groups. The aim was to improve the judgment writing skills of AD&SJs, which would increase the trust of people in the judicial system. It also

focused on enhancing the self-learning capacity of the judicial officers by developing their decision-making skills. In the previous quarter, four groups of AD&SJs completed the GTP.

In the current quarter, two more groups (XI & XII) finished the training, involving 48 AD&SJs. **Batch-XI** training took place from 16<sup>th</sup> October, 2023, to 21<sup>st</sup> October, 2023, while **Batch-XII** training was from 6<sup>th</sup> November, 2023 to 11<sup>th</sup> November, 2023. This GTP covered various **topics** such as:

- > Judgement Writing (Sequence & Structure) Civil Case Appraisal of Evidence thereof.
- > Judgement Writing (Sequence & Structure) Murder Trial Case Appraisal of Evidence thereof.
- > Guidelines for Judgement Writing-Murder Trial Cases.
- > Guidelines for Judgement Writing-Civil Cases.
- Use of precedents in judgment writing, how to find ratio decidend and obitor dicta.

To enrich the participants' competence and capacity, the Punjab Judicial Academy invited the Hon'ble Judges and renowned experts specializing in the legal field. They shared their knowledge and experiences with the participants to enhance their judicial competence and judgment writing skills. The training sessions included interactive discussions and practical assignments.

#### b) GTP for Civil Judges-cum-Magistrates:

Similarly, the General Training Program was specifically designed to meet the in-service training requirements of all 936 Civil Judges-cum-Magistrates. This comprehensive initiative will be carried out in 39 groups, each consisting of 25 participants, with the main objective of refining the judgment writing abilities of civil judges to enhance litigants' trust in the judicial framework. The program is designed to augment the self-learning capabilities in judgment writing among judicial officers. Commencing from February 13, 2023, five groups have been successfully completed in previous quarters.



In this regard, a Recruitment Committee was constituted for the said








